COOPERATION AGREEMENT

The Faculty of Economic Studies and Law, University of Pitesti, Romania, Pitesti, Targu din Vale no.1, corresponding email iccu2008@yahoo.com and The Faculty of Law, Humanities and Social Sciences, Tbilisi Humanitarian Teaching University, Georgia, 0144, Tbilisi, Monk Gabriel Salos Ave.N31, corresponding email thu-posta@thu.edu.ge have agreed to sign this agreement in order to contribute to the research development in the field of common interest.

Article 1. The two parties will support the organization of a scientific conference, in 26 May 2023. This conference is intended to be the 15th International Conference, Special Edition ("History," Culture, Citizenship in the European Union - In Memoriam Eugen CHELARU"). This collaboration will be extended to other cooperation domains which is subjected consequently to concluding other agreements. The conditions of this collaboration are valid for events organized by the Faculty of Law, Humanities and Social Sciences.

Article 2. University of Pitesti pledges itself to provide the necessary material and logistical support (call for papers, conference program, posters, conference website, promoting the conference on the conference website, exhibition space for the conference, projectors) and the publishing of the accepted papers in the Conference Volume (published in C. H. Beck Publishing House and indexed in the international databases). All the submitted papers will be subjected to a double reviewing process by the members of the Scientific Committee.

Article 3. The Faculty of Law, Humanities and Social Sciences will propose 2 (two) members one in the Scientific Committee and one member in the Organizing Committee.

Article 4. The Faculty of Law, Humanities and Social Sciences will publish 2 (two) papers into the Conference Volume, after the double reviewing process, without any fee.

Article 5. The Faculty of Law, Humanities and Social Sciences will propose or invite a Keyspeaker in Conference, with the acceptance of the mean organizer (University of Pitești).

Article 6. The Faculty of Law, Humanities and Social Sciences will disseminate the call for papers and other conference information among the academic community using its communicational channels.

Article 7. The Faculty of Economic Sciences and Law, University of Pitesti will post the Tbilisi Humanitarian University logo on these materials. Also, a short presentation of the Tbilisi Humanitarian University will be posted on the conference website.

Article 8. The Faculty of Economic Sciences and Law, University of Pitesti, Romania will assist in identifying and booking proper accommodation for the conference participants and manage all the organizing aspects of the conference (conference materials and website designing, organizing the reviewing process, organizing the conference rooms or Skype sessions etc.).

Article 9. The Faculty of Economic Sciences and Law will collect participation fees.

Article 10. Other institutions may be accepted as co-organizer. The Faculty of Economic Sciences and Law, University of Pitesti, Romania will reserve the right to decide upon the acceptance and the invitation of the co-organizers.

Article 11. The present agreement is written into English. It comes into effect as soon as the two parties sign it and it will be valid for 3 (three) years.
