

ASSOCIATION AGREEMENT

1 June, 2011

The Bolashak Karagandy University, a private institution, in the person of the head of the university, Nurlan Dulatbekov, acting on the grounds of the statute, and the Tbilisi Humanitarian University in the person of Valentina Sakvarelidze, named below Parties, concluded this Agreement of the following:

1. SUBJECT OF THE AGREEMENT

The subject of this agreement is the Parties collaboration in the scientific and educational fields, which is of mutual interest.

2. OBLIGATIONS OF THE PARTIES

The Parties assume obligations to:

- provide a regular exchange of information and provide mutual assistance in research and methodological work;
- provide student, postgraduate, associate and teacher exchange;
- provide assistance in the professional development of the teaching staff by pursuing studies (doctoral, postgraduate and MA courses);
- provide practical training opportunities for teachers and students of the university;
- organize cooperative educational and cultural events, seminars and conferences;
- provide assistance in publishing research and scientific work;
- provide reviewing of research works of students and teaching staff;
- provide participation of scholars in the dissertation committees of the Parties;
- provide academic exchange of teachers, students and masters;
- provide with information on the new published materials, such as books, monographs, research-scientific works and send out advance copies;
- provide experience exchange in the use of the latest teaching methods;
- provide all concerned information of the Parties.

3. OTHER TERMS

The described collaboration work is mutually beneficial and reasonable. The terms of mutual settlement of accounts are to be defined with additional agreements.

In case of need the Parties may conclude agreements on fulfillment of certain kind of work with the agreed deadline for the work to be done and mentioning the obligations of the Parties.

4. TERM OF VALIDITY

4.1. This agreement will come into force as soon as it has been signed, and it is permanent. It is subject to changes or can be terminated at the initiative of every Party.

5. FINAL TERMS

5.1. To fulfill the described agreement clauses the Parties are to follow the existing legislative system.


5.2. All changes and add-ins in this agreement are valid in case they have been committed in writing and signed by both Parties.
