2. Lines of cooperation

2.1. The Parties intend to promote cooperation along the following lines and forms:

\* development of new educational products, implementation of educational projects and execution of joint scientific studies and developments;

\* integration of efforts in training the scientific personnel of the highest qualification;

\* holding of joint seminars, conferences and other scientific events;

\* initialization, development and implementation of integration projects in the sphere of education;

\* drafting and publication of educational literature, educational-methodological aids, joint scientific monographs, articles, scientific-methodological recommendations, popular science materials, and others, including, periodical, scientific publications;

\* integration of the intellectual resources for participation in national projects of the Czech Republic and Georgia, international projects, programs, contests and bids;

\* exchange of the results of performed research efforts, educational, scientific and information technologies, mutual consulting;

\* engagement of students and residents in the research efforts along the priority lines;

2.2. The list of the lines and forms of cooperation is not exhaustive and may be extended and supplemented by consent of the Parties.

## 3. Obligations of parties.

3.1. The Parties undertake:

\* to render assistance in implementation of the joint projects and programs in the manner, in the volume and by the methods provided for by individual agreements and other documents, sighed by the parties in execution of the present Agreement;

\* not to disclose any information, which the Parties recognized to be confidential;

\* regularly to discuss the issues associated with implementation of the lines of cooperation;

\* to review the problems arising in the course of execution of the present Agreement, to take consorted decisions on the former.

- 3.2. The provisions of the present Agreement may not be viewed as infringing on the rights of the Parties in respect of independent implementation of the projects and actions along the lines listed in the present agree-
- 3.3. Questions of financial maintenance of cooperation, will dare the parties by negotiations and signing of separate agreements and reports.
